Sarah is the current Chair of the Women's Bar Association Political Action Committee. She is also a past President and long-serving board member of Women Everywhere: Partners in Service Project, which is a collaborative effort of lawyers and judges coordinating volunteer activities to help women and children.

Sarah is committed to promoting and advancing women lawyers. To that end, Sarah co-founder of the Illinois Trial Lawyer's Women's Caucus. She is also on the ITLA Board of Managers.

Sarah has been an integral part of the WBAI since joining as a law student at DePaul University College of Law. She joined the WBAI Board as a Director in June of 2018 and subsequently served the Board as the Financial Secretary and Second Vice President. During her time as a WBAI member, Sarah has served as a section editor of the WBAI newsletter and on numerous Annual Dinner and Judicial Reception committees and as co-chair of the Judicial Evaluation Committee.
